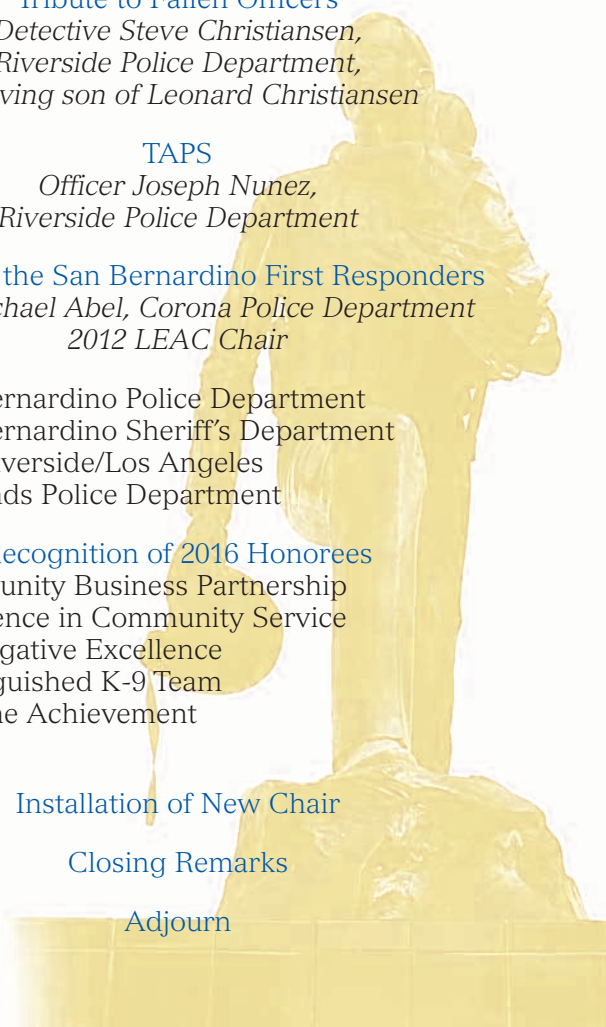

### California Highway Patrol - Riverside

On November 4, 2005, Officer Robert Stage became a member of the California Highway Patrol (CHP). Since September 1, 2010, he has been stationed at the Riverside area and is currently assigned to the Safety Services Program (SSP), which is responsible for providing service to all state facilities in the Riverside Area.

Before joining the California Highway Patrol, Officer Stage served not only his community but his country as well by enlisting in the United States Marine Corps (USMC). Officer Stage spent four years with the USMC, achieving the rank of Corporal at the time of his honorable discharge. After the USMC and before joining the CHP Academy, Officer Stage also served as a Correctional Officer.

Officer Stage has been instrumental in developing and promoting a partnership between the community and the CHP. He is actively involved in well over 20 events in the community throughout the year. Officer Stage teaches young adults the importance of safe driving practices through his Impact Teen Driving presentations, and he provides education to families on child-restraint safety as a Certified Child Passenger Safety Technician. He is also actively involved in

high schools and elementary schools throughout the community.

Even outside of his work with the schools, Officer Stage remains very involved with the youth of the community. During the Christmas holidays he participates in the Department's CHiPs for Kids program as well as Toys for Tots. These community programs provide gifts for less fortunate families and their kids. ### California Highway Patrol - Temecula

Officer Harvey Ray has spent 26 years in law enforcement with the California Highway Patrol (CHP), working at the Temecula Area office for the past 10 years. He has been a Community Enhancement Officer for the past three years and involved in countless community service programs and projects.

Officer Ray coordinates numerous public safety events throughout Riverside County as a uniformed representative of the California Highway Patrol. Most notably, he has taken a personal responsibility in the local community service program dedicated to improving traffic safety related issues near schools within the unincorporated areas of Temecula, Murrieta, Lake Elsinore, Menifee and the surrounding communities. The CHP Senior Volunteer Program assists Officer Ray with increasing communication and building trust between law enforcement and all segments of the community. He has identified and involved partners in a collaborative effort to resolve traffic safety problems, which impacts the quality of life in the community. He anticipates problems rather than reacting to them.

Officer Ray implemented a bicycle safety helmet program to increase the safety of children riding their bicycles to school. He was commended for the success of the program by the CHP and the Murrieta Unified School Board Administration.

Officer Ray also provides on-going training sessions for state, county, and city departments involved in community outreach partnerships. He provides workplace violence training and assists with developing action plans for state departments within the local community.

### **Riverside County Sheriff's Department - Jurupa Valley**

Riverside County Sheriff's Sergeant Richard Heard supervises the Special Enforcement Team for the cities of Jurupa Valley and Eastvale. In January 2015, Sergeant Heard and his team were tasked with finding a solution for the continuous homeless population that has plagued the city of Jurupa Valley. He realized that uprooting the homeless from their camps would not solve the problem. In fact, they would just set up a new camp, either in Jurupa

Valley, Eastvale, or another nearby city.

Throughout the year, Sergeant Heard's team set out to contact the homeless population throughout Jurupa Valley. The team took the time to learn about each individual and figure out how the Riverside County Sheriff's Department could help them. Sergeant Heard helped brainstorm the idea of helping the homeless by finding temporary and permanent housing for those that qualified. The Special Enforcement Team called around the Riverside County area and located county personnel, from the Housing Authority, that were willing to assist in this endeavor. Several meetings took place between the Special Enforcement Team and members from the Housing Authority, Veteran's Affairs, Mental Health Department, and the Probation Department. Sergeant Heard and his team were able to find housing for several of the homeless, which included many veterans.

In addition, during his off-duty time, Sergeant Heard makes it a point to help the homeless in the Jurupa Valley and Eastvale area. For several years, on an ongoing and regular basis he has donated and delivered blankets, clothing, shoes and personal hygiene items to the homeless. He also coordinates donations through non-profit organizations to help the homeless and their families.

Sergeant Heard's on and off duty passion, tireless dedication, and respect for those less fortunate community members are admirable examples for us all. He has, and continues to, selflessly assist our homeless and improve the communities we serve. LEAC is proud to honor Sergeant Richard Heard for Excellence in Community Service.

### Riverside Police Department

For the past nine years, Officer Jesse Castro has served as a police officer for the Riverside Police Department. In addition to his regular patrol duties, Officer Castro also volunteers as the lead Police Explorer Advisor. As a former Explorer himself, Officer Castro understands the importance of mentoring our young men and women in the all-volunteer Explorer Program. The Police Explorer program accepts interested youth between the ages of 14 to 21 who are willing to volunteer their time to the police and work at community events. In turn, the Explorers are taught and practice a selfless commitment to the community.

Through Officer Castro's leadership over the past 8 ½ years, the program has grown from 30 Explorers to over 100. The kids donate their time at events such as DUI checkpoints, patrol ride-alongs, and the Riverside Youth Court. The Explorers help provide high visibility at community events, such as the Mariachi Festival, Chili Cook-Off, and Tamale Festival. They provide traffic control, community clean-up at parks, as well as participate in the Christmas Toy Drive, El Protector Soccer Clinic, and at Riverside Police Foundation events. Under Officer Castro's leadership, the Explorers volunteer at 5K events, including the Hometown Heroes Run, Citrus Heritage Run, and the Mission Inn Run. They provide service at the Riverside Air Show, Riverside Peace Officers Memorial, fingerprint children in the Child-ID Safety Program, and at LEAC's Annual Award Ceremony. Officer Castro's Explorer post has provided over 21,000 hours of community service.

Officer Castro also donates countless hours of his own time providing leadership and career guidance to these hard working young people for jobs within and outside law enforcement. He challenges his kids to become more responsible citizens in their communities. He realizes that not all the Explorers will choose a career in law enforcement, but Officer Castro provides them with skills and discipline they will benefit from as they transition into adulthood. Without a doubt, Officer Castro's efforts with the Explorer post, both on and off duty, are the main catalyst for the success of his post.

Officer Jesse Castro is commended for his exceptional leadership in the Riverside Police Explorer Program and LEAC is proud to honor him for his Excellence in Community Service.

## Excellence in Community Service

### Corona Police Department

The City of Corona has seen a great increase in the number of calls-for-service regarding unlawful encampments, trespassing, and mentally ill subjects. This problem led to the creation of the City of Corona HOPE Team. HOPE stands for Homeless Outreach and Psychological Evaluation. Officer Wade Arens and Officer David Dopson were selected for the inaugural team because they possess a genuine interest in providing alternatives to the homeless and the mentally ill. With a vast array of resources they ventured into Corona's city parks, alleyways, flood control channels/tunnels, and wooded areas to find the homeless and offer them a new life with these assistance programs. The HOPE Team transported some of them to the DMV for new identification cards or the County Recorder for new birth certificates. Some were driven to locations to begin a multi-year program of self-help and job training. Others volunteered to be driven to drug and alcohol rehabilitation facilities.

When some were reluctant to change their ways with free assistance, choosing to continue trespassing on private and public lands, the HOPE Team could switch to enforcement mode, utilizing existing state and local laws to make the quality of life better for the citizens of Corona as well as the homeless themselves.

As of January of 2016, the HOPE Team has performed the following:

- Handled 730 calls-for-service for transients and involuntary psychiatric holds
- Made 734 property checks
- Made 221 pedestrian/vehicle checks
- Evaluated 114 mentally ill subjects for involuntary psychiatric holds
- Made 111 arrests
- Issued 113 citations for California Municipal Code violations and Traffic Violations
- Adjusted their schedules to assist officers on patrol with enforcement of park nighttime curfew
- Attempted to assist 265 individuals off the streets with available resources
- Tagged and cleaned up 88 unlawful encampments
- Conducted 50 meetings and presentations
- Relocated or placed 37 homeless individuals into assistance programs and/or affordable or free housing

## *Investigative Excellence*

*Award Criteria: Recognize an officer for exceptional execution of responsibilities by successfully concluding a major investigation or by demonstrating outstanding investigative or interrogative techniques in the course of an investigation during 2015.*

### **Riverside County Sheriff's Department - Jurupa Valley**

On Sunday, September 13, 2015, patrol deputies responded to a burglary at the Riverside County Animal Control Shelter in the city of Jurupa Valley. When deputies arrived, they discovered several of the shelter dogs were either missing or loose and sadly, two of the dogs were fatally injured. Riverside County Sheriff's Investigator Ted Gonzales was assigned as the lead investigator.

When Investigator Gonzales arrived at the shelter, he immediately interviewed the staff and learned that the property was monitored by a security surveillance system. Investigator Gonzales spent several hours personally reviewing the video and ultimately learned that an adult male had climbed over the wall onto shelter's property and was possibly the suspect.

The following day, using the surveillance video and images, Investigator Gonzales quickly identified the burglary suspect. Investigator Gonzales submitted his findings to the District Attorney's Office and to the Court and obtained an arrest warrant for the suspect.

Investigator Gonzales continued his efforts to apprehend the suspect, and decided to contact the Riverside County Sheriff Department's Press Information Officer. Collaboratively, they put together a press release that included all of the suspect's information. A press conference was held and the public was encouraged to assist law enforcement with the apprehension of the suspect.

## *Investigative Excellence*

Due to the high amount of media coverage of the investigation, the suspect decided to turn himself in. Through his attorney, the suspect contacted Investigator Gonzales and made the arrangements. Finally, on September 17, 2015, the suspect returned to California, was arrested and booked into jail.

Within four days of being assigned the investigation, Investigator Gonzales followed dozens of leads, found two of the stolen dogs and returned them to the shelter, and identified and arrested the suspect who had fled the state. Investigator Gonzales showed strong initiative, leadership, and professionalism in the way he swiftly managed this investigation. He was able to effectively work with several bureaus, outside agencies, and efficiently delegated tasks to members of his team. It is Investigator Gonzales' strong work ethic that continues to demonstrate why he is an invaluable asset to the Riverside County Sheriff's Department and Jurupa Valley Station's Investigations Bureau. LEAC is pleased to honor Investigator Ted Gonzales for his Investigative Excellence.

### Corona Police Department

On September 8 and 9, of 2015, three calls were received at the Corona Police Department's Dispatch Center of reported bomb threats at Centennial High School. This led to closing down the school campus. Officer Michael Placencia, a newly assigned School Resource Officer at Centennial High School, had developed trusting relationships with students and quickly learned from uninvolved students about an Instagram exchange that talked about "swatting" (calling in fake threats to law enforcement). The Instagram involved another 16 year-old female Centennial student.

Corona Police Sergeant Dan Leary and Senior Detective Andy Bryant contacted the 16 year-old female student and learned the context for the threats, which was online gaming and "swatting." At the request of Sergeant Leary and Senior Detective Bryant, this student communicated with the suspect online. The student was able to prompt the bomb threat suspect to provide identifying information, including that he was a 17 year-old male who lived in Colorado Springs, Colorado. This male also admitted that he personally called in the bomb threats to Centennial High School. It was also learned the suspect made bomb threats to schools in the Las Vegas, Nevada. Corona Police Detective Gary Griffiths was assigned to investigate the Las Vegas school bomb threats.

Because of the interstate implications, the investigation was complex and multi-level. Instrumental in this investigation was FBI Special Agent Shannon Snead and his team who assisted by drafting multiple subpoenas, and Assistant US Attorney Billy Essayli who coordinated the Federal response with the FBI and local law enforcement in Colorado Springs. Ultimately, FBI agents served a search warrant at the suspect's home, interviewed him, where the suspect admitted to phoning in the bomb threats to Centennial HS and the schools in Las Vegas. The suspect was arrested and charged with two felony and two misdemeanors.

For their tremendous work in gathering and cooperating with the appropriate outside agencies, LEAC is honoring Officer Michael Placencia, Corona Police Sergeant Dan Leary, Senior

Detective Andy Bryant, and Detective Gary Griffiths. It is because of their investigative excellence that they were able to bring an end to a string of crimes that had a huge impact on the school district, our community, and the Corona Police Department, while making an example of this suspect to thwart further similar activity.

### Hemet Police Department

In early 2015, a series of armed robberies, including home invasions, occurred in the City of Hemet. For each of the robberies, the suspect, vehicle, and firearm descriptions were remarkably similar.

On August 11, 2015, 19 year-old Sergio Salcedo, and a 17 year-old female were detained during a "suspicious circumstance" call. Hemet Police Investigator Jessica Tuttle was assigned the case.

After initial interviews, Salcedo and the juvenile were released. However, during a search of their vehicle, Investigator Tuttle recovered several stolen items that appeared to be related to the series of armed robberies that had occurred in their city. Also, in the car was a wallet with the birth certificate of 19 year-old Dupree Gordon. After some research, Investigator Tuttle found Gordon matched the physical description of one of the robbery suspects, and was also a suspect in shooting from August 5, 2015 in Beaumont where 9mm casings were recovered.

Investigator Tuttle began an extensive investigative search, including social media sites. On Facebook, Investigator Tuttle

located a “friend” connection between Salcedo, the female juvenile, and Dupree Gordon. While reviewing the Facebook photos, Investigator Tuttle found photos of Dupree Gordon wearing the same shoes that were seen in a surveillance video from one of the robberies. A “selfie” of the 17 year-old female showed her posing with a Ruger 9mm semi-automatic pistol. She was also wearing clothes that linked her to the robberies. Through diligence, Investigator Tuttle also found a link between the 17 year-old female to another 16 year-old female who also matched one of the robbery suspect descriptions.

Investigator Tuttle created and showed photo line-ups of these four suspects to the individual robbery victims, which led to the positive identification of Dupree Gordon and the two female juveniles as being involved in the robberies. Through the use of surveillance and GPS technology, Investigator Tuttle located and arrested all four suspects. Upon his arrest, Dupree Gordon was in possession of a Ruger 9mm handgun that was ultimately linked to all of the robberies. During Investigator Tuttle’s suspect interviews, all four gave full confessions and described their roles in the robberies. Furthermore, Investigator Tuttle obtained confessions to other unknown crimes these suspects committed. For her investigative excellence, LEAC is proud to honor Investigator Jessica Tuttle.

### Riverside County District Attorney’s Office & Riverside County Sheriff’s Department - Riverside

In 2013, Supervising District Attorney Investigator Matthew Remmers and Riverside Sheriff Lead Investigator Andy Liu were assigned to the Sexual Assault Felony Execution (“SAFE”) Unit. During that time, a “Cyber Tip” appeared in SAFE’s email which came from the FBI Nevada Branch, who had a warrant for William Clyde Thompson for child pornography. The FBI shared that Thompson had some association with David Yoder from Desert Hot Springs.

Investigators Remmers and Liu learned the Department of Homeland Security also had an open investigation on David Yoder. Remmers offered his expertise and assistance with the open investigation, and ultimately Investigator Liu and he took the lead. With the assistance of Desert Hot Springs Police Department, Remmers and Liu contacted Yoder at his home. That was the beginning of an extensive investigation that revealed a huge internet child pornography ring.

## Investigative Excellence

In 2012, a nine year-old child “John Doe” with special needs was a student attending school in Desert Hot Springs. David Yoder was Doe’s teacher. Yoder began the grooming process by befriending Doe’s single mother. Doe’s mother trusted Yoder, allowed him to care for Doe, and eventually allowed her son to stay the night at Yoder’s home. One year later, Doe’s mother lost custody of Doe. In lieu of her son being placed in foster care, Doe’s mother allowed Yoder to have temporary custody of Doe. During this time, Doe slept in the same bedroom with Yoder, who kept the bedroom door locked. While Doe lived with Yoder, he was encouraged to run naked through the house and act like “Batman.”

Periodically, Yoder had roommates including the wanted William Clyde Thompson. While living with Yoder, Thompson would befriend young boys and solicited them to be photographed in their underwear and other costumes. It was learned that Yoder and Thompson ran a business of photographing young boys in skimpy underwear for months, and eventually paid the young boys to masturbate in front of them along with several other horrific acts of pedophilia.

The investigation led to a Grand Jury indictment of Yoder and several other pedophiles. The jury trial for Yoder began in January 2016 and lasted six weeks. On February 17, 2016 the jury convicted Yoder on 10 counts of Lewd Acts with a Child, Human Trafficking, and Persuading a Child and Conspiracy. Yoder’s sentencing hearing is pending, but he’s looking at spending the next 30 years of his life in prison. Trials are pending on two other defendants.

### Riverside County Sheriff’s Department - Lake Elsinore

During the month of January 2015, Riverside County Sheriff’s Department Investigator Robert Cornett was assigned as the lead investigator in an attempt murder case. The victim in this case was shot four times and left for dead. Early on into the investigation, Investigator Cornett learned the victim’s girlfriend, also the mother of his child, initiated a murder-for-hire scheme against the victim.

During an extensive investigation that involved authoring and serving 43 search warrants of homes, businesses, phone records, and social media, Investigator Cornett identified five suspects who conspired in the murder-for-hire plot. One of the suspects was also wanted by the US Bureau of Alcohol, Tobacco, and Firearms for the illegal sale of firearms.

As part of proving this difficult conspiracy case, attention to every detail was imperative. For example, during the monitoring of one of the suspect's jail phone calls, Investigator Cornett heard the suspect ask the caller whether investigators knew about his "arm." The suspect then quickly ended the conversation. Believing this conversation seemed unusual and may have relevance to the crime Investigator Cornett authored and served a search warrant on the suspect to x-ray his arm. The x-ray revealed a lodged bullet in the suspect's arm. Investigator Cornett further learned that the bullet lodged in the suspects arm occurred during the attempted murder of the victim.

This is only one example of many, where Investigator Cornett remained diligent by following every lead. He also coordinated investigative efforts with a number of outside law enforcement agencies, including the San Bernardino Sheriff's Department, Riverside Police Department, Bakersfield Police Department, and the US Border Patrol.

It is Investigator Cornett's meticulous attention to detail and excellent investigative work over a six-month period that ultimately identified five dangerous suspects who conspired to kill another for profit. Three of these suspects are currently in-custody pending trial while the other two are believed to have fled the country.

From 2012 through late 2013, there were four unsolved murders in the City of Riverside. Although Riverside Police investigators believed these four homicides were committed by members of a violent local street gang, all leads had been exhausted unsuccessfully and the offer of substantial rewards brought forth no new information.

In 2014, detectives from the Riverside Police Department's Gang Unit and Homicide Bureaus met and strategized methods to develop new investigative leads and methodology for the re-examination of the physical evidence. Of most significance was the work of Detective Joseph Miera and then Detective, now Sergeant Chad Collopy. Specifically, they became familiar with and researched a covert investigative technique called a "Perkins Operation" which is the use of professional informants. Detective Miera and Sergeant Collopy sought the advice and intelligence of other law enforcement agencies that had experience with the "Perkins Operation." They then



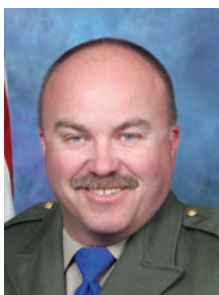

met with the Riverside County District Attorney's Office where they developed and implemented a legally sound plan to use this covert technique.

During 2015, several covert operations using the professional informants were employed and resulted in the identification of suspects in three out of the four unsolved homicides in the City of Riverside. Consequently, three suspects were identified in the murder of a 14 year old victim, one suspect was identified in the murder of an adult female, and two suspects were identified in the murder of an adult male. In each of these cases, one or more of the identified suspects admitted to committing the murder and named accomplices. Five of the six suspects were charged with murder in the first degree, as well as hate crime and gang allegations.

The closing of these high profile murders in the City of Riverside improved the public's trust in their police department and provided relief to the community that had been terrorized by these unsolved murders. Detective Joseph Miera and Sergeant Chad Collopy are honored by LEAC for their exemplary work ethic, organizational skills, determination, dedication, professionalism, and outstanding investigative techniques.

### California Highway Patrol - Riverside

On April 29th, 2015, at approximately 10:00 p.m., a fatal hit-and-run collision occurred on Sultanas Road north of State Route 74, near Winchester. Two pedestrians were struck when the suspect swerved his vehicle into their path, running them down and leaving them in the roadway. One victim died and the other suffered major injuries. The only clues remaining at the scene were broken vehicle parts.

CHP Officer Joshua Carter assisted with the collection and identification of the parts, and by piecing those parts together he was able to identify the suspect's vehicle as a Ford Mustang. The parts were swabbed for DNA, and profiles for both victims and potential suspect were collected. Officer Carter was able to develop a detailed damage profile of the suspect's vehicle based on the recovered parts and supervised the creation of "Wanted" flyers and bulletins.

Officer Carter continued his diligent quest for justice. He assisted with a neighborhood canvas of the area, searched for additional clues related to the suspect and his vehicle, assisted with a public information campaign seeking the support of the local community, and managed all leads related to the case.

While canvassing the area for leads and speaking to residents, Officer Carter learned the involved vehicle was hidden in a

driveway, approximately one mile from the collision scene. The vehicle was recovered and processed for DNA in order to place it at the collision scene. This resulted in additional DNA evidence found on the rear of the Mustang.

The suspect's family members were contacted and revealed the suspect driver had fled to Mexico to avoid prosecution. On May 8, 2015, Officer Carter discovered the suspect was attempting to re-enter the United States. Officer Carter coordinated with the California Highway Patrol's (CHP) Mexico Liaison Unit to ensure the suspect was detained until he could respond. Officer Carter was able to arrest the suspect and return him to Riverside County, where he was booked for his crimes. The suspect was ultimately convicted of numerous felonies and sentenced to state prison.

Based on Officer Carter's dedication, as demonstrated by his work with this investigation, LEAC proudly honors CHP Officer Joshua Carter for his Investigative Excellence.

## Distinguished K9 Team

*Award Criteria: The honor to be presented to a team for a particular outstanding job on a case, or a long term high level of performance in the field of police K-9 work. The award recipient will be honored for an act in which the aforementioned risked severe personal injury or death to accomplish their mission, or to save another threatened with severe personal injury or death in the act of a K-9 Team.*

### Corona Police Department

Officer Corporal Chad Fountain has been an Officer for the Corona Police Department for 14 years and has been a K9 handler for almost 10 years. He began his K9 career in March of 2006, handling a large Czech Shepard named Oldo. Corporal Fountain worked with Oldo on patrol and was part of the department's SWAT team until Oldo became ill from cancer and passed away in April of 2011. During their time together, Corporal Fountain and Oldo were responsible for numerous searches and netting over 200 arrests. The team also competed in several K9 competitions, resulting in a number of awards.

In June of 2011, Corporal Fountain selected and began training with his new K9 partner, a Belgian Malinois, named Spike.

They finished training and began working the streets in July of 2011. Spike was cross-trained as both a patrol and narcotics dog and also works with the department's SWAT team. Corporal Fountain and Spike have conducted countless searches for suspects and narcotics and are responsible for over 100 arrests.

Corporal Fountain has received numerous accolades from supervisors regarding his work ethic and control of his K9 partners. He has planned, outlined, and modified a yearly curriculum of training for the department's teams that covers a variety of potential incident scenarios and even uncommon, unique ones. He also developed a new form that clearly documented the ongoing K9 training for all of the department's teams. When a new dog team was selected, Corporal Fountain took the initiative to go by the training field to see how the new team was progressing by offering support and guidance. When the new K9 team completed their training, he volunteered to have his schedule adjusted so that he could ride with the new team as a K9 FTO. He continually trained with new scenarios to ensure the new K9 team was ready to be on its own.

Corporal Fountain also saw the importance of having an operational plan, in addition to the policy manual. He wrote the Corona Police Department K9 Operational Manual, which was ultimately approved by the department and implemented. It was the first such manual approved by the department. Seeing the benefits of this new instrument, other teams within the department are in the process of implementing their own operational manuals. Chad Fountain was promoted to Corporal in July of 2015 and partner Spike was retired on January, 08, 2016. Corporal Fountain is commended for his initiative and dedication to the K9 team and his contributions overall to the department. LEAC is pleased to honor Corporal Fountain and his partners, Oldo and Spike, as a Distinguished K9 Team.

## Moreno Valley Police Department

Riverside County Sheriff's Department Deputy Matthew Schmidt and his K9 partner "Dre" have been a team since 2013 and currently are assigned to the Moreno Valley Station. Matthew has developed many collaborative relationships with numerous federal and state narcotics teams in Southern California. This K9 team's collective activity in 2015 has resulted in 61 felony arrests, 18 firearms recovered, 74 K9 apprehensions, 76 scene searches, and the recovery

and seizure of over 19 pounds of methamphetamine and 10 pounds of marijuana.

In August of 2015, Deputy Schmidt initiated a traffic stop on a Chevrolet truck near the south end of Moreno Valley. Deputy Schmidt spoke with the driver and obtained the drivers consent to search the truck. Deputy Schmidt retrieved Dre and conducted an exterior “sniff” of the truck. Dre alerted near the truck’s engine compartment where Deputy Schmidt located a pound of methamphetamine. Deputy Schmidt obtained the drivers consent to a search of his residence where an additional nine pounds of methamphetamine was recovered.

In October 2015, Deputy Schmidt and Dre responded to the 15200 block of Zaharias Street in Moreno Valley to assist patrol with an assault with a deadly weapon investigation. The suspect had stabbed one of his neighbors after a dispute and retreated into his residence. Numerous police units responded and surrounded the residence as Deputy Schmidt organized an entry team to apprehend the suspect. After numerous announcements, the suspect refused to exit and Deputy Schmidt’s team of officers entered the residence and began a methodical search for the suspect. They located the suspect in the kitchen holding an unknown glass object in one hand and a butcher knife in the other. The suspect threw the glass object at the deputies, dropped the knife, and retreated backwards. Less-lethal force options were deployed on the suspect but were ineffective.

Deputy Schmidt gave the bite command and deployed Dre. While Dre was biting the suspect’s arm, the suspect grabbed another knife and stabbed Dre’s torso. The force of the stabbing punctured Dre’s lung and fractured a vertebrae. Deputy Schmidt was able to get Dre out of immediate danger as the other officers subdued the suspect. Obtaining a military field dressing kit, Deputy Schmidt applied direct pressure to Dre’s injury and was able to control the bleeding. Deputy Schmidt rushed Dre to a 24-hour emergency veterinarian hospital where Dre received treatment. Dre underwent two surgeries and since December 2015, has fully recovered and is back to full duty.

For their exemplary service and achievements, LEAC is proud to honor Deputy Matthew Schmidt and his K9 partner “Dre” as a Distinguished K9 Team.

Although Officer Calica is currently assigned as the Court and Evidence/Property Officer, he's always open and happy to handle additional duties and complex projects. Officer Calica goes above and beyond for his fellow workers, supervisors, managers, and the public by consistently providing the highest level of service. During the month of October 2015, a Riverside Community Hospital chaplain called the Riverside Police Department to report a male threatening to commit suicide by jumping from the hospital's parking structure. The suicidal man was an employee of the hospital.

Officer David Lim and other officers responded to the structure to handle the call. Officer Lim rushed to the fifth level of the structure and saw the despondent employee sitting on a wall with his legs dangling over the edge and the chaplain engaged in a conversation with him. As the situation progressed, the employee became irritated. His emotions and behavior were unpredictable, with him occasionally shouting, "Get back! Don't come any closer or I'm going to jump."

Being extremely concerned that the man was going to jump, Officer Lim cautiously approached him and was able to get within inches as the chaplain engaged the subject to pray with him. Officer Lim utilized this brief moment to rescue the employee, quickly grabbing his shoulders and safely pulling him backwards off of the wall. The man was treated by paramedics and transported to a mental health facility.

Officer Lim is to be commended for his quick response, decisive actions, and calm demeanor during this life-threatening crisis as he placed himself at great risk to save the employee's life. Based on Officer David Lim's act of valor, the Riverside County Law Enforcement Appreciation Committee proudly recognizes him for the Valor award.

In the early afternoon of August 30, 2015, California Highway Patrol Officers Christopher Horton and Jose Renteria were patrolling the eastbound 91 Freeway, west of Central Avenue, in the City of Riverside. As they approached the Central Avenue off-ramp, they saw a wrong-way driver traveling westbound on the off-ramp, using the off-ramp as a freeway entrance.

Officer Horton immediately activated his patrol vehicle's emergency lights and while turning, he attempted to stop the wrong-way vehicle. The officer's actions

caused the wrong-way driver to enter the construction zone area adjacent to the eastbound lanes. The driver failed to respond to the lights and siren and continued westbound running over construction cones. Fearing for the safety of the motorists on the 91 Freeway, Officer Horton accelerated his patrol vehicle and pulled ahead of the wrong-way driver.

Once in front of the driver, Officer Horton turned the front of his patrol car into the wrong-way driver's path, forcing the driver and vehicle to come to a stop. This heroic act prevented the wrong-way vehicle from leaving the construction zone and entering the busy traffic lanes.

Officers Horton and Renteria exited their patrol vehicle and detained the driver without further incident. During the subsequent investigation, Officer Renteria determined the driver was highly intoxicated and arrested him for driving under the influence.

Without hesitation, Officers Horton and Renteria placed the safety of the public above their own. Were it not for their diligent patrolling, keen observations, and immediate response, it is likely that this wrong-way driver would have entered the busy freeway lanes, and a deadly head-on collision would have occurred.

## Corona Police Department

On March 5, 2015, just before midnight, Corona Police Officer Michael Neff was dispatched to a traffic collision on Foothill, east of Main Street. While responding, dispatch advised the vehicle was on fire, and a driver was trapped inside. When Officer Neff arrived, the vehicle was fully engulfed in flames.

Officer Neff grabbed his fire extinguisher and ran towards the burning vehicle. He saw a woman sitting in the driver's seat screaming for help. She was obviously trapped inside the car. Officer Neff immediately began extinguishing the fire. As he was fighting the fire, a private citizen arrived and rendered aid to the trapped driver. Together they were able to pull the woman out of the burning vehicle.

Firefighters and paramedics arrived and began treating the driver. Officer Neff learned that she suffered two broken legs and a dislocated hip as a result of the crash. Due to Officer

Neff and the private citizen's efforts, the driver did not suffer any burns to her body. Officer Neff conducted an investigation and later arrested this driver for suspicion of driving under the influence.

Officer Neff showed extraordinary courage in the face of imminent danger. Were it not for Officer Neff's heroism, courage, and quick actions, the driver likely would have suffered severe burns, if not death.

Based on Officer Neff's acts of valor, the Riverside County Law Enforcement Appreciation Committee proudly recognizes Corona Police Officer Michael Neff for the Valor award.

### Riverside County Sheriff's Department - Cabazon

On April 16, 2015, Deputy Phillip Pike and Deputy Gabriel Garcia responded to a residential burglary call in the areas of Cabazon and Whitewater.

The burglary suspects fled the area in a black Chevrolet Impala prior to the deputies' arrival. In their attempt to escape, the suspect's vehicle traveled at more than one hundred miles per hour, ran a red light, and collided with an older Chevrolet Suburban that was occupied by a family of six.

As a result of the collision both vehicles spun around through the intersection, severing a light and power pole before coming to rest in a dirt field. A third vehicle was also involved which came to rest about 150 feet from of the suspect's vehicle.

As the Deputies Pike and Garcia responded to the scene of the crash and Deputy Jason Miller arrived to assist, they saw six downed high voltage power lines on the road next to the Impala and Suburban. Both vehicles were engulfed in flames with all occupants still inside. Risking injury Deputies Pike and Garcia used their fire extinguishers, positioning themselves between the live downed high voltage power lines and the vehicles that were on fire. Deputies Pike and Garcia were

able to suppress the flames long enough to allow Deputy Miller to approach and remove the injured occupants of the Suburban. Deputies Pike and Garcia continued to suppress the flames until additional safety personnel arrived on scene.

Both burglary suspects were trapped inside the Impala and had to be extricated by the fire department. Deputies Miller, Pike, and Garcia continued to assist the other injured parties until additional ambulance personnel arrived on scene.

The two burglary suspects and a passenger of the Suburban suffered serious life-threatening injuries and were transported to local hospitals where one of the burglary suspects ultimately died due to his injuries. The other five occupants of the Suburban were transported and treated for minor to moderate trauma and burn injuries.

Had Deputies Pike, Garcia, and Miller not placed themselves at significant risk of injury to isolate the live electrical wires and suppress the vehicle fires long enough to quickly move the victims to safety, additional lives would have been lost.

Based on Deputy Pike, Garcia, and Miller's heroic acts of valor, the Riverside County Law Enforcement Appreciation Committee proudly recognizes them for the Valor award.
